**IMPORTANT:** It is very important that you read this sheet so that you supply **ALL** the necessary documents needed to complete the application.

- Applicants must use one of the programs contracted Optometrists or any Tribal/Indian Health Facility Optometrist.
- Muscogee Tribal Citizens are eligible for the Tribal Vision Program once every 2 years.
  - Muscogee Tribal Diabetic Citizens are eligible for the Tribal Vision Program every year. **(If you use an outside Optometrist please include DM Statement from your doctor's office with application)**
- Applicant **MUST** reside in Oklahoma.
- Applicants **MUST** provide a copy of Updated Muscogee Nation Citizenship card. **(Please note we will NOT accept your Certificate of Degree of Indian Blood (CDIB) card)**
- Applicant **MUST** provide a copy of Social Security Card.
- Applicant **MUST** provide a front and back copy of Insurance Cards **(Medicare, Medicaid or private insurance, if applicable)**
